



FORM FOR NOTIFICATION AND POSTAL VOTING

This form must be received by CTT Systems AB (publ) **no later than Thursday 30 April 2026**.

The board of directors has resolved that shareholders may also exercise their voting right at the Annual General Meeting by postal voting pursuant to the provisions in CTT's articles of association.

Note that **shareholders whose shares are nominee-registered must register the shares in their own name in order to vote**. Shareholders should inform their nominees well in advance before **Tuesday 28 April 2026**. Instructions for this can be found in the notice of the Annual General Meeting.

For postal voting, proceed as follows:

- Complete all the requested information above.
- Select the preferred voting options below regarding how the shareholder wishes to vote.
- Print, fill in, sign and send the form in original to CTT Systems AB, P.O. Box 1042, SE-611 29 Nyköping, Sweden, or send the completed and signed form to ctt@ctt.se.
- If the shareholder is a natural person who is personally voting by post, it is the shareholder who should sign under *Signature* above. If the postal vote is submitted by a proxy of the shareholder, it is the proxy who should sign. If the postal vote is submitted by a legal representative of a legal entity, it is the representative who should sign.
- A signed and dated power of attorney signed by the shareholder shall be enclosed if the shareholder votes by post by proxy. If the shareholder is a legal entity, a registration certificate or a corresponding document for the legal entity shall be enclosed with the form. Power of attorney forms are available at the company's website, www.ctt.se.

Further information regarding postal voting

Shareholders cannot give any other instructions than selecting one of the options specified at each item in the form. If a shareholder wishes to abstain from voting in relation to a matter, kindly refrain from selecting an option. A vote (*i.e.* the postal vote in its entirety) is invalid if the shareholder has provided the form with specific instructions or conditions or if pre-printed text is amended or supplemented.

Only one form per shareholder will be considered. If more than one form is submitted, only the form with the latest date will be considered. The form latest received by the company will be considered if two forms are dated at the same date. An incomplete or wrongfully completed form, or a form without valid authorisation documentation, may be discarded without being considered.

The postal voting form, together with any enclosed authorisation documentation, must be received by CTT no later than 30 April 2026. A postal vote should be withdrawn up to and including 30 April 2026 by contacting CTT by e-mail to ctt@ctt.se.

For complete proposals for resolution, kindly refer to the notice and other documents to the Annual General Meeting available on CTT's website. The proposed resolutions set out in the notice may be changed or withdrawn. CTT will disclose such adjustments through a press release, whereafter the shareholders have the right to submit a new form.
